

# Construction Safety Course for Project Managers

Effective 1 Jun 2001, the Factories (Safety Training Courses) Order requires: "any person who is appointed as a Project Manager to be in charge all construction activities in building and engineering construction worksites of a contract sum of S\$10 million or more" to attend and pass the "Construction Safety Course for Project Managers" before undertaking such project.

At the end of the course, participants besides helping their companies meet the MOM requirement, will also be familiar with safety and health legislations to deal with hazards in the construction worksite and prevent accident through the implementation and audit of the safety management system.
