OVERVIEW

The construction sector has been one of the top contributors of workplace accidents in Singapore. The occurrence of accidents frequently leads to injury and fatality that would affect the sector's reputation, productivity and profitability. In addition, non-compliance of the legislative WSH requirements would subject the violating parties to prosecution by the competent authority as well as civil proceedings by the injured parties, and the estate of the deceased. It is thus important for parties in the construction sector to be aware of the relevant legislative WSH requirements including those specific requirements pertaining to high risk construction worksites, take and implement appropriate safety measures to prevent, if not minimise, the occurrence of such worksite accidents.

OBJECTIVE

This course gives an overview of the legislative requirements for high risk construction worksites as defined under the WSH (Construction) Regulations. The WSH (Operation of Cranes) Regulations which is legislated to deal with crane accidents at worksites will be highlighted in the discussion.
